

The Corporation of the Town of Atikokan

By-law No. 02-17

Being a by-law to Establish Water Rates and Sewage Service Rates.

WHEREAS the *Public Utilities Act* being Chapter P. 52 R.S.O. 1990, Part III, Sec. 28 provides that the Council of a Municipal Corporation, owning or operating a public utility may enact by-laws for the maintenance and management of the works and to set rates, etc.; and

WHEREAS the *Municipal Act 2001, as amended*, provides that a Council of a municipality may by by-law provide for imposing a sewage service rate;


NOW THEREFORE the Council of The Corporation of the Town of Atikokan
ENACTS AS FOLLOWS:

1. THAT By-law No. 01-16 be hereby rescinded.
2. THAT rates for water and for sewage service supplied to owners and occupants of all property are hereby imposed as indicated in Schedule "A" attached hereto and forming part of this by-law.
3. THAT water and sewage service levies become due and payable as follows:
 - 25% (twenty-five percent) of the current year's annual rate on February 28, 2017
 - 25% (twenty-five percent) of the current year's annual rate on April 28, 2017
 - 25% (twenty-five percent) of the current year's annual rate on July 31, 2017
 - 25% (twenty-five percent) of the current year's annual rate on September 29, 2017
4. THAT a late payment charge of one and one-half percent (1.5%) per month in default on the first of each month.
5. THAT default of payment the Corporation may shut off the water supply after a period of sixty (60) days in arrears of due date, and may be recoverable by action in a Court of competent jurisdiction.
6. THAT a service charge shall be imposed for turning "ON" and "OFF" the water supply with the exception of an emergency turn OFF to carry out repairs and turn ON after repairs are completed as per the current fees by-law.
7. THAT any request for work to be done after normal working hours will be billed as per current fees by-law with the exception of an emergency.
8. THAT this By-law shall come into force and take effect the 1st day of January, 2017.

READ a FIRST, SECOND and THIRD time and FINALLY PASSED this 23rd day of January, 2017.
